- We use cookies to track visitor movement on our site
 - We use Google Analytics to aggregate data (daily, weekly)
 - This data helps us to understand interests
 - We use the data for direction in developing content

 - We want information to be relevant
 - This cookie tracks IP-address and no specific personal data
- We do NOT use 3rd Party cookies to follow you on the internet
 - We do post on industry Buyers Guides with links to this site
 - We do promote our business on social media with links

You decide if you want to share Personal Data

- We limit personal data collection to:
 - Name

- Company
- Work City, Country
- Work Phone
- Personal data is used only for AFT business activities
- Sharing your data does provide Benefits:
 - Name/email gives access to new product info
 - O Contact form:
 - Product or process assistance
 - Technical support from our Regional Engineering staff
 (Sales & Application Engineers, in-house technical staff)
 - Quote response
 - Resource Registration provides more on-line for Customers
 - Product bulletins
 - Case studies
 - Maintenance and Service Support
 - Alerts on new products







CRM System (Customer Relationship Management)

Personal Data in the CRM:

- Customer Contact List
- Correspondence name/email/company Examples:
 - Quotes
 - Technical reports
 - Quality claims
 - Visit reports
 - Service logs...

Personal Data - Retention

- Resource Center Registration
 - You can manage or delete your account at any time
 - Accounts inactive for more than 18 months are deleted
- We do NOT make data public or sell data
- Business Contact Information may be duplicated to our CRM system
 - Data is available to Sales & Application Engineers assigned to support a specific Customer or Corporation
 - You can ask that your data be deleted in our Contact List by emailing: <u>marketing@aft-global.com</u>
 - We do not redact information on quotes, quality claims, technical reports or other correspondence (Name/email/Company)
 Deletion of this data would be based on the Retention policy of the respective source documents







Personal Data - Employment Candidates

You decide if you want to share Personal Data for hiring consideration

- We try to limit personal data collection to:
 - > Name
 - Work Title
 - o **Email**
 - Location (City, Country)
 - Phone
 - o Resume
 - Job Attribute Ratings
- Sharing does provide benefits
 - Consideration for a specific job
 - Consideration in our job pool (optional)
- Data removal
 - At any time you can request to be removed from consideration for a job or removed from the job pool
 - This would isolate your personal data into a retention folder, which may include additional item you have shared. Specific retention time depends on the local retention policy relative to applicable laws and internal AFT policies.

Personal Data - Website Data Breach

- Our website does have 24/7 monitoring:
 - We have experienced threat alerts
 - All recognized within minutes
 - Never any data loss
 - All threats are reviewed for improvement ideas
 - Audit reviews are done regularly
 - Continuous Improvements made
- If a data breach did occur with a release of personal data:
 - We would notify anyone who may have data released with particulars such as when and what data was included
 - We would make reports as necessary to authorities
 Note: In Europe we report to Finnish authorities within
 72-hours for any EU-citizen data released
